How do I open and manage my account?	<p>To open your account:</p> <ul style="list-style-type: none"> You must deposit the minimum amount of £10,000. If your account hasn't reached the minimum deposit amount by the end of the 14 days funding period then the account will be closed and your funds will be returned. You must be a limited company based in the UK. Your application must be made by either a director of the company or the company secretary. You must have the authority to open an account on behalf of the company and obtain consent from the owners and directors of the business. We will do the appropriate data checks of the owners and directors of your business to validate their identity. You will need to nominate another UK bank account in the same business name that will be used to fund your Allica Bank savings account. This is also where we'll send your money if you choose to make a withdrawal. <p>Also, bear in mind:</p> <ul style="list-style-type: none"> You can open your account online. You can view your balance and communicate through our internet banking service. To request a withdrawal, simply give our customer services team a call. You can fund using Faster Payments, but please note that we don't accept CHAPS payments. 		
Can I withdraw money?	You can request a withdrawal at any time, providing you give us 180 days' notice. You cannot withdraw your funds earlier than this. The 180-day notice period is based on calendar days and begins the day we receive your request. Note that, should your balance fall below our minimum deposit, we will need to close your account.		
When can I close the account?	You can close the account at any time, providing you give us 180 days' notice.		
Additional information	<p>We will pay you your interest in full, without the deduction of income tax.</p> <p>This savings account is a limited offer and can be withdrawn at any time prior to you opening your account.</p> <p>If you change your mind within 14 days of opening your account, you can cancel your account without penalty or notice.</p>
